
#### SCORAI Europe Workshop, 29-30 Sept 2016



SCORAI Europe hosted a workshop prior to the Degrowth conference on sustainable consumption and social justice in a constrained world

On 29-30 September, thirty international researchers and experts came together in the vibrant city of Budapest to discuss emerging knowledge and strategies around the theme of sustainable consumption and social justice. In partnership with the Resource Cap Coalition and hosted by the Office of the Commissioner for Fundamental Rights in Hungary, workshop delegates discussed how sustainable consumption can become attractive, as an equitable and empowering "new normal" involving the good life for all in a constrained world. The conclusions were presented in a special session dedicated to sustainable consumption at the 5th Degrowth Conference. Nine papers were presented and discussed, including the notion of consumption corridors linking limits to wellbeing, as well as the need for absolute reductions. The full conference proceedings, including discussant contributions, will be available soon on the SCORAI Europe webpage. The workshop was organised by Edina Vadovics, Sylvia Lorek and Marlyne Sahakian from SCORAI Europe; Philip Vergragt from SCORAI North America; and Klara Hadju from the Resource Cap Coalition.

For the first time in the history of SCORAI Europe workshops, the carbon footprint of the workshop was calculated (in tonnes of carbon dioxide – see figure, right). SCORAI Europe's strategy of organising workshops back-to-back with other events sense from a sustainability makes perspective: the footprint of the workshop alone had been 15.07 tonnes of CO<sub>2</sub> compared to an adjusted 10.2 tonnes due to several people also joining the International Degrowth Conference following the workshop.






The local workshop co-organiser, GreenDependent, has a tradition of offsetting the carbon footprint of events by planting native fruit trees, which also help to preserve local biodiversity. The number of trees to be planted is usually determined in such a way as to allow the offsetting of an event's carbon dioxide emissions within 1-2 years (instead of over the entire lifetime of the trees). However, for an international event with 10.2 tons of  $CO_2$  footprint, several hundred trees would be needed.

At the workshop, participants were offered the opportunity to donate money for the purchase of fruit trees. From the donations thus collected, and with an additional donation of 10 trees from the nursery to support the good cause, 40 native fruit trees were purchased and planted by GreenDependent, together with several workshop participants who live in the area.

#### Smart CSOs Lab workshop, 13-15 Oct 2016

On 13-15 October, the Smart CSOs Lab convened a workshop on 'Pathways to the Great Transition' in Barcelona (Spain). Some 30 representatives from civil society, research and funding organisations discussed theories of change, strategies for more systemic activism and the further development of the Smart CSOs community. During workshop sessions, slow lunches and even slower, delicious dinners, the Re.imagining Activism guide formed the basis for innumerable discursive ventures into activism, research and funding for the Great Transition on individual, organisational and societal levels. Among the many themes discussed, sustainable consumption featured prominently, next to education, social inclusion, and resilient communities.

#### GRF Third International Conference, 27-29 June 2017

The Global Research Forum's third international meeting, hosted by the Institute of Development Studies (IDS) and the Science Policy Research Unit (SPRU) at the University of Sussex, has the theme "Sustainable Lifestyles, Livelihoods and the Circular Economy" and will take place in Brighton (UK) on 27-29 June 2017. The conference will convene researchers, development practitioners, policy makers and representatives from business, government and civil society to explore critical links between the circular economy, sustainable lifestyles and livelihoods and the Sustainable Development Goals. We will examine the potential for, pathways to, and politics of advancing a global transition from the current linear "throw-away" model to sustainable production and consumption systems and practices in "circular economies." In keeping with GRF's emphasis on global perspectives, we will explore these questions across different regions and communities, in both industrialized and developing countries.






#### **Edited Books**
